TO
DECLARATION OF CONDOMINIUM

Pursuant to Florida Statute 718.110, Amendment of Declaration, and pursuant to Section 13, Amendments, of the Declaration of Condominium of Trade Winds Condominium, Inc., recorded in Official Records Book 549, Pages 391-663, of the Public Records of Monroe County, Florida, and as amended from time to time, hereby offer the following certificate of said association for the amendment of said declaration.

WE, the undersigned officers of TRADE WINDS WEST CONDOMINIUM, INC. hereby certify that on February 5, 1983, at a duly noticed meeting of said association, and its Board of Directors, a resolution for the following was duly adopted by 100 percent of both the Board of Directors and the members of said association to take effect immediately upon filing of this certificate. Said amendment was as follows:

1. Section 10 of the Declaration of Condominium presently entitled, Use Restrictions, is changed to read, Use and Ownership Restrictions.

2. Paragraph 10.11 is added and shall read, one family shall own only one apartment other than the one they occupy. The intent hereof is to allow one family to own no more than two apartments in said condominium.

3. Added as 10.12 is the following: no time/share estates shall be allowed to be created in any apartment of the condominium, nor shall multiple ownership be allowed that would in effect give multiple entities the right to use the apartment at different times during the year.
